## FAQs?

### Q - What do you mean by June 2024 as base month?

A - Whichever level you qualify in June 2024 that will be considered as your base month and to qualify for the pool you need to complete the defined criteria as mentioned in the posters attached.

### Q - What happens if I maintain a lower level than my base level during the pool period in any month?

A - If you maintain a lower level than your base level during the pool period in any month, then your business of that month will not be counted in the criteria for the pool.

### Q - What happens if I do not qualify for any level in one or two months during the pool period?

A - Any new entrants in the month of June 2024 during the pool period must maintain or up their level for minimum 5 months and also meet the defined PV criteria. July onward the entrants of the pool must maintain their base level or up their level in all the remaining months of the pool period and also meet the defined PV criteria.

### Q - What happens if I qualify for the first time in August 2024?

A - If you qualify for the first time in August 2024, then the same month's level will be your base level. In this case, you need to maintain or up your level in all remaining months till November 2024 and complete the total PV criteria.

### Q - Can I do self PV as per criteria in multiple invoices?

A - Yes, self PV can be done in multiple invoices.
